IRAN'S FEMICIDE CRISIS: SUPPRESSED, SILENCED AND STRANGLLED

INTRODUCTION

Femicide remains a relentless and pervasive crime in Iran, with women killed at an alarming rate—at least one every other day in 2024. These murders are not random acts of violence; they follow deeply entrenched patterns of control, punishment, and impunity. Women are most often killed by male family members, within their own homes or in remote locations where their deaths can go unnoticed. While each case is unique, there are common motives: Enforcing family honor, silencing defiance, or responding to perceived disobedience. In many cases, children and other relatives bear witness to these brutal acts, left to navigate the lasting trauma. The perpetrators are often strikingly deliberate in their violence yet reckless in their actions, as though they believe they are above the law—and, in many cases, they are.

Strangulation cases have emerged as a disturbing trend in 2024, with multiple women killed using scarves—the very hijab meant to protect them turned into a weapon against them. In one particularly chilling case, a woman was strangled with a balloon string after a birthday party, an act that epitomizes the recklessness and dehumanization underlying many of these crimes. Dress code-related murders have been committed by family members enforcing their perceived modesty standards, mirroring the state's violent crackdown on women's autonomy.

Reports from various NGOs confirm a surge in femicide cases, though the reasons remain uncertain. It is unclear whether the rise reflects an actual increase in killings or just greater visibility due to families and activists being more courageous to speak out. Meanwhile, the Islamic Republic of Iran set a grim record in 2024 for the highest number of female executions in almost two decades. Women, some of whom have suffered severe domestic abuse, face disproportionately harsh sentencing for similar crimes compared to their male counterparts, exposing the gendered nature of Iran's legal system. The UN fact-finding mission to Iran has recently classified the systematic violence against women as the crime against humanity of persecution on the grounds of gender.

In the absence of official statistics and amid widespread efforts to silence victims' families and activists, this report aims to document and analyze patterns of femicide in Iran. It examines locations, methods, motives, and the identities of both victims and perpetrators. It also compares the data gathered in 2022 and 2023 to identify initial trends and tendencies. The report concludes with recommendations for civil society, the Iranian government, and the international community. The report is produced by the Alliance for Rights of All Minorities (ARAM), a network of activists promoting human rights in Iran. It studies 211 cases of murders of women, including 172 claimed femicides, documented in ARAM's "StopFemicideIran" (SFI) database, exposing a harrowing reality: women in Iran are systematically targeted, their murders carried out with brutality and impunity, while justice remains elusive.

ABOUT StopFemicideIran

ARAM launched its SFI initiative in 2020 in response to the brutal killing of the 14-year-old Romina Ashrafi, allegedly at the hands of her father. SFI seeks to combat the phenomenon of femicide in Iran and pay tribute to the victims, employing a three-prong approach to achieve this mission:

- **Documentation:** SFI monitors and documents suspected cases of femicides using publicly available information. This data is essential for identifying patterns, conducting advocacy, and naming the countless victims who die anonymously.
- **Education:** SFI provides comprehensive information about femicide to human rights activists and broader society in Iran and beyond. This includes insights into the root causes of femicide and strategies for prevention and response.
- **Empowerment:** SFI enhances the capacity and competencies of grassroots civil society actors to advocate for the rights of women affected by femicide. This empowerment is achieved through different cultural, religious, psychosocial, and legal tools that pave the way for meaningful and sustainable social and behavioral change.

During its initial years, SFI has primarily focused on the documentation component of its work, recording and analyzing hundreds of femicide incidents to discern relevant patterns.


WHAT IS FEMICIDE?

While there is no universally accepted definition, the terms “femicide” or “feminicide” are commonly used to describe the deliberate killing of women and girls because of their gender. Femicide represents the most extreme form of gender-based violence against females and requires the perpetrator to have a gender-related motive for the killing. Such motives may include the desire to exercise power over females or prevent or punish them for behavior deemed socially unacceptable for women, perceptions of entitlement and ownership over women, pleasure, or sadistic desires. In most cases, femicides are perpetrated by the victims’ husbands, male relatives, or family acquaintances within the confines of the home. Femicides may also occur at the hands of the state through the imposition of capital punishment or the extrajudicial (excessive) use of force by government officials.

In the context of the Middle East, including Iran, a prevalent form of femicide is the phenomenon known as “honor killings,” which are defined as crimes committed in the name of perceived family honor. The perpetrators are typically male family members who – sometimes with the support of the patriarchs – kill another female family member for actions believed to contravene societal traditions or misinterpreted religious demands or tarnish the family’s reputation. Such acts may encompass perceived sexual or behavioral transgressions as well as instances of incest and rape.

METHODOLOGY

This report is based on femicide cases that occurred in Iran in 2024, as documented in SFI’s database. To compile its records, SFI relied on various sources, including official Iranian government sources, newspaper articles, and social media reports. It registered femicides committed by private individuals and the Iranian State when it could identify at least three of the following criteria: date and place of the incident; name, age or ethnicity of the victim; victim-perpetrator relationship; method of the killing; the perpetrator’s stated motive for the killing; and, in instances of femicide through capital punishment, the woman’s motive for the crime she was convicted of. All recorded cases resulted in the death of the victim.




SFI does not count reports of suicide reportedly committed by females to prevent their family members from committing femicide, nor does it document cases of women being robbed and subsequently murdered. While these incidents may align with the broader societal and legal context in Iran that disadvantages women, it is difficult to attribute a gendered motive of the perpetrator, thus excluding them from the femicide classification.

The data collection for femicides in Iran faces significant limitations. Documenting femicide requires establishing gender-related motives, but investigative authorities often lack the awareness or competence to recognize such motivations. In Iran, this challenge is exacerbated by structural barriers, including government censorship, media restrictions, and institutional corruption. The Iranian government does not provide accurate or comprehensive statistics on gender-related killings, and official data on violence against women is scarce. Severe restrictions on journalistic reporting further suppress public awareness of femicide. Iran ranks among the most repressive countries for press freedom, with the government effectively controlling public information. Authorities closely monitor traditional media, and even social media posts are subject to surveillance, though citizens use digital tools to bypass some restrictions. This censorship explains why some reports on femicides disappear from the internet after publication. The government justifies these controls under the guise of public safety, further discouraging the documentation of femicide cases.

Law enforcement agencies also contribute to underreporting. Cases involving domestic violence or family members are often dismissed as private matters rather than crimes requiring state intervention. Authorities frequently misclassify femicides as disappearances or unrelated violent crimes, leading to inaccurate public records. In marginalized regions such as Sistan and Baluchistan, additional barriers—including limited internet access, poverty, and a lack of official identification documents—hinder data collection. Ethnic minorities, who are disproportionately affected, face systemic discrimination and are underrepresented in government institutions, further eroding trust in law enforcement and criminal justice systems.

Beyond these structural challenges, methodological limitations arise from the reliance on open-source data. Newspapers, social media, and NGO reports may be subject to biases and incomplete information. Government censorship, fear of persecution, and social stigma likely result in significant underreporting. Families of victims may choose not to publicize femicide cases, while journalists and activists often self-censor due to state repression. Further, high-profile or particularly violent cases receive disproportionate coverage, while incidents in rural or marginalized communities are underreported. This selection bias affects the ability to assess broader patterns of femicide. Open-source reports often lack crucial details about the circumstances surrounding a femicide, making it difficult to determine gender-related motivations. Some cases may be misclassified due to incomplete information, and misinformation or unverified social media reports risk distorting the findings. While cross-referencing and validation are essential, they are limited by censorship and the restricted availability of primary sources.

Given these constraints, SFI's database does not represent an exhaustive record of all femicide incidents in 2024. The actual number of femicides is likely to be higher. Nevertheless, the available data offers insight into the landscape of femicides in Iran, unveiling the gruesome events and their underlying narratives.



KEY FINDINGS OF THE DATA ANALYSIS

Based on the analysis of 211 recorded murders of women and girls including 172 claimed cases in 2024, the report identifies the following patterns and stories of femicides:

1. Femicide cases have increased significantly compared to 2023.

- The 172 recorded femicide incidents represent an average of one killing every other day or at least 14 killings per month.
- This figure reflects an increase of approximately 16% compared to the incidents documented in 2023. The increase may be attributed to an actual surge in cases or greater willingness among affected families, journalists, and activists to speak out.

2. Most victims are young, and their names are buried with them.

- An examination of victim age distribution shows that over a third were young women, aged between 15 and 35.
- The youngest recorded victim was a two-month-old baby girl, while the oldest was an 86-year-old woman, highlighting the wide age range affected by femicide. The infant was strangled by her father, who also murdered her 19-year-old mother due to a family dispute. The elderly woman was killed by a relative for her jewelry.
- The exact age of 71 victims—more than a third—remains unknown.
- Public records also do not reveal the names of 117 femicide victims, nearly two-thirds of all documented cases, reflecting the significant level of anonymity surrounding these crimes.

3. Reported femicides occur primarily in Tehran province and western Iran.

- Femicides were documented in virtually every province of Iran, demonstrating that women and girls remain vulnerable to violence regardless of their location.
- Tehran province reported the highest number of femicides within a single province, with 42 cases accounting for 24% of the total. This highlights the widespread nature of gender-based violence in the capital region. While Tehran is socio-economically and ethnically diverse, the available data lacks details on the victims' backgrounds, making it difficult to determine any direct correlation between femicide and ethnicity or socio-economic status.
- A considerable share of femicides—38 cases, or 22% of all recorded incidents—occurred in western Iran, spanning the provinces of Fars, Ilam, Kermanshah, Khuzestan, Kurdistan, and West Azerbaijan. These areas are characterized by tribal structures and ethnic diversity, suggesting a possible link between tribal affiliations and gender-based violence.
- Notably, the densely populated provinces of Esfahan and Fars together accounted for just 17 femicide cases—less than 10% of the total, which is most likely due to lack of reporting.
- The relatively low number of recorded femicides in Sistan and Baluchestan, with only nine reported cases (under 5%), is striking and may point to gaps in reporting or other societal factors affecting the documentation of such crimes in this region.

4. Victims are brutally killed.

- Physical violence is a prevalent means of controlling and silencing women. A total of 53 women were stabbed or killed with a sharp object, accounting for nearly one-third of all recorded femicides.
- Gun violence was also a significant factor, with 45 women—over one-quarter of all victims—shot to death.

- 13 women were strangled in brutal ways. A particularly gruesome killing occurred in Teheran where a man murdered his wife the day after their child's birthday, using a string from a balloon. He hid her body under their child's bed for two nights before secretly burying her. During this time, he lied to their children, telling them their mother was lost.
- Other documented methods include beatings, burning, being run over by a car, decapitation, and being thrown from windows, highlighting the extreme brutality of these crimes.
- Notably, the perpetrators applied multiple methods of killing their victims in 12 documented cases, which demonstrates their determination, brutality, and feeling of vengeance. For instance, 32-year-old Masoumeh was thrown from a bridge, stabbed, and burnt by her husband for a financial dispute. Another young woman, Parinaz, was beaten and hung by her husband, who attempted to make the crime look like a suicide.
- Another disturbing tendency is the fact that perpetrators were not only brutal with their victims but also with themselves. In several instances, they committed suicide after killing the women—a testimony to the poor mental state they were in. For instance, after killing his wife and three children, a 39-year-old man hung himself.
- 31 killings were state-perpetrated through execution, although according to international standards, they may not be categorized as femicides. In seven more likely cases, the women were executed for killing their husbands, which stands in stark contrast to the lenient sentences husbands face for killing their wives. In 11 other cases, the women were sentenced to death for murder, though the victims' identities and relationships to them remain largely unknown. The remaining executions were reportedly for drug-related offenses, ineligible for classification as femicides.

5. In the vast majority of cases, the perpetrators were known to the victims.

- In more than 80% of documented femicide cases, the victim knew her killer. The data particularly underscores the widespread nature of extreme intimate partner violence, with husbands responsible for nearly half of the cases (90 incidents). Other male relatives and acquaintances—including fathers, brothers, colleagues, fiancés, in-laws, uncles, suitors, and sons—also account for a significant number of cases, with 72 femicides committed by family members other than the husband.
- In 7 cases, the perpetrator's identity remains undisclosed. However, based on the circumstances of the killings, they appear to be private individuals rather than state actors. For example, Nasrin, a 37-year-old Afghan immigrant, was found stabbed to death in her apartment. Sources reported that she had an argument with her husband and separated a year before her death, but information about her killing or the perpetrator's identity were still unknown.
- The Iranian state was directly involved in 33 murders of women, including 31 executions of women. One case involved excessive use of force against a woman who allegedly failed to comply with the regime's dress code and died as a result. In another incident of state-sponsored violence, intelligence officers in plainclothes fatally shot a woman in a car. The motive behind the shooting and any potential accountability measures remain unknown.

6. Most femicides occur as a result of family disputes.

- The data reveals that the primary motive behind femicide incidents in Iran is rooted in family disputes, which account for 94 cases. These conflicts often stem from a variety of issues, including dissatisfaction with domestic responsibilities, such as the wife's cooking, and other interpersonal tensions within the family.

- Another motive is honor, with 27 cases—roughly 14% of the total count—attributed to perceived violations of family honor. The number of honor-related killings is relatively low and contradicts common assumptions that femicides in Iran are equal to so-called “honor crimes,” and demonstrates the variety and complexity of reasons why femicide crimes occur in Iran. Nonetheless, “honor” based crimes represent deep-seated cultural beliefs surrounding honor and shame in parts of Iranian society, which can drive individuals to commit violent acts in an attempt to “protect” or salvage family honor.
- In 11 cases, a financial dispute was the driving motive behind the killings, whether in relationships, disagreements over inheritance, or property disputes. In one instance, a woman was stabbed by her boyfriend over a financial dispute arising from a joint investment that they were planning. In another case, a 25-year-old woman was shot by her brother, who wanted to ensure that she did not inherit the property of their deceased father.
- Other contributing factors include requests for divorce, rejection of marriage proposals, or refusal of second marriages, which were cited in 13 cases.

7. Femicide does not spare children

- Children are deeply impacted by femicide in three ways. In 14 cases—around 7% of recorded incidents—children were direct victims.
- Eight victims had been subjected to child marriage before their deaths. Among them was 17-year-old Nazanin Baluchi from Gohach, forced into marriage at 14. After three years of abuse, she left her husband. Weeks later, her cousin accused her of dishonoring the family, beat her, and demanded a confession. A relative intervened, preventing her murder that night. The next morning, he returned and shot Nazanin twice in the head in front of her 15-year-old sister.
- In at least 10 cases, children were killed along with their mother—simply for being at the crime scene of the femicide and thus becoming a potential witness to testify against the perpetrator. For example, a man killed his pregnant wife and two children after a family dispute related to the illness of one of the children. These multiple murders show the ruthlessness of the perpetrators - they do not even mind killing their own children (and other family members in some instances) to get their way.
- In another 14 cases, children witnessed the killing of their mothers, some even testifying against the perpetrators. For example, a five-year-old exposed the truth behind his mother Nastaran’s murder in Tabriz. Initially, the husband denied any involvement, but after the child’s testimony and supporting evidence, he confessed.

INDIVIDUAL TRAGEDIES

In Baharestan County, a 39-year-old man murdered his wife and their three children—two daughters, aged 1 and 16, and a 10-year-old son. He strangled the children with a scarf before killing his wife by smashing her against a wall. After the killings, he took his own life. The motive remains unknown.

Farshad Azkat, a man from Paveh, confessed months later to murdering his pregnant wife, Bayan Amiri, and their two-year-old child. Initially staging the crime as an accident, he admitted to intentionally driving his wife and child into the waters of Daryan Dam on April 2, 2024, causing their deaths by suffocation. He cited his child’s illness and marital issues as motives. Upon learning of the crime, Bayan’s mother, Sedri Sharifi, suffered a fatal heart attack.

On July 2, 2024, a young woman identified as “P.S.” was thrown down the stairs of her apartment by her husband in Abadan, suffering a fatal brain injury. She remained hospitalized for eight days before succumbing to her injuries. Initially, the husband claimed she had fallen accidentally, but their six-year-old daughter, who witnessed the attack and was also beaten, testified against him. Following her account, the husband was arrested and confessed to the murder.

On April 4, 2024, in Varamin, Tehran, 55-year-old Talat was killed by her husband, Asghar, who pushed her into a well, later claiming he did so to "preserve honor." He initially confessed to the crime but denied premeditated murder in court. His two daughters testified about years of abuse and demanded his execution, while his two sons forgave him, preventing a harsher sentence. On October 7, 2024, the court sentenced him to three years in prison and ordered him to pay compensation (diyah) instead of ordering his execution – a typical punishment for the murder of a male victim.

Arezoo Shirkhani had just taken the first step toward to divorce her husband, initiating the legal process against him in Sabzevar County. But when she returned home, her husband was waiting. The first axe blow shattered her hands as she raised them in defense. The second struck her head, killing her instantly. Their conflicts had been escalating, and now, as she sought to leave, he made sure she never would.

ROOT CAUSES OF FEMICIDE IN IRAN

The documented femicide cases in Iran highlight several underlying issues, even though they do not always provide detailed insights into their root causes. Women in abusive relationships receive little to no support from their communities or the Iranian government, leaving them vulnerable to violence. Shelters, legal aid, and counseling services are largely absent, making it difficult for women to escape abuse. Economic dependence on male relatives further limits their ability to leave violent situations, while social stigma and shame discourage victims and their families from seeking help.

A major driver of femicide is the deeply ingrained belief that men have the authority to control women's lives. Perpetrators often view femicide as a means to resolve family disputes or reclaim perceived honor, reflecting systemic gender inequality. In some cases, the women are presumably pressured into suicide by their families before family members can get their hands dirty. These patriarchal norms are particularly pronounced in tribal communities in western Iran, where many femicide cases occur. In these regions, strong emphasis on family honor exerts social pressure to kill female relatives accused of bringing shame to the family. Additionally, the widespread practice of child marriage exacerbates this vulnerability, as young girls are often forced into marriages with abusive husbands, stripped of autonomy, and denied the ability to seek protection.

The Iranian government not only fails to protect women from gender-based violence but actively enforces structures that endanger them. Iran's authorities have adopted increasingly draconian laws that further strip women and girls of their rights. On December 13, 2024, the "Law on Protecting the Family through the Promotion of the Culture of Chastity and Hijab" came into force, imposing severe penalties—including the death penalty, flogging, and long prison sentences—on those who oppose Iran's compulsory veiling laws. While the law was abrogated the following day, it signals the government's willingness to violently suppress women's rights, further reinforcing a culture where violence against women is normalized and justified.

Beyond the legal endorsement of gender-based oppression, a pervasive culture of impunity protects femicide perpetrators from consequences. Families frequently hesitate to report femicides, as perpetrators are often close relatives or the family's primary breadwinner. Even when cases are reported, Iran's legal system offers multiple avenues for perpetrators to evade accountability:

- Article 220 of the Penal Code exempts fathers and paternal grandfathers from Qisas (retaliatory punishment) if they kill their children or grandchildren.
- Article 209 requires the victim's family to pay half of the Diyat (blood money) for the execution of a male perpetrator—a deterrent in cases where the killer is a family member.
- Article 302 allows exemption from Qisas if the victim is accused of a crime under Sharia law, such as adultery or same-sex relations—justifications often cited in femicide cases.

- Article 630 & Article 226(2) permit husbands to kill their wives on suspicion of adultery without facing punishment.

The legal system not only shields perpetrators but also discourages victims and their families from seeking justice. Even when cases reach the courts, lenient sentencing and early releases are common, undermining deterrence. For instance, the “Preventing Injury of Women and Improving Their Security Against Misbehavior” law, passed in April 2023 after 12 years of deliberation, purportedly introduces prison sentences (5 to 15 years) for intentional femicide. However, this contradicts Iran’s general criminal law, which typically punishes murder with the death penalty. Civil society organizations warn that this law does little to deter femicide, as perpetrators may exploit loopholes to secure early release.

Another significant challenge is the lack of official femicide data. The Iranian government does not systematically publish statistics on gender-based killings, forcing NGOs and human rights organizations to fill the reporting gap. The absence of transparent data further obscures the scale of the crisis and limits efforts to hold perpetrators accountable.

Further, law enforcement officers often lack the competence—or willingness—to recognize femicide, intervene in domestic disputes, or hold perpetrators accountable. Reports indicate that authorities frequently dismiss cases of domestic violence or honor killings as “family matters,” reinforcing the perception that men have a right to control women’s lives and bodies.


The combination of discriminatory laws, state repression, ineffective law enforcement, and entrenched patriarchal norms fosters an environment where femicide remains widespread and largely unpunished. Until systemic legal and cultural changes take place, women in Iran will continue to face the ever-present threat of violence—both from their own families and from a state that refuses to protect them.

TRENDS AND TENDENCIES FROM 2022 TO NOW

Analyzing femicide data from 2022 to 2024 collected by SFI reveals persistent patterns as well as shifts. The number of documented femicides has fluctuated significantly over the past three years, highlighting both data gaps and changing documentation efforts. In 2022, 191 femicide cases were recorded. In 2023, reported cases dropped by 18%, possibly due to increased censorship and reporting difficulties rather than an actual decline in femicides. However, in 2024, the number surged again to 172 cases—a 14% rise from 2023. There have been no relevant legal, social, or structural changes in Iran that would explain these fluctuations. Instead, the increase in 2024 may reflect greater public resistance and activist-driven documentation rather than an actual rise in killings.

Across all three years, honor killings and domestic violence remain the most common forms of femicide. Women are frequently murdered by male relatives—husbands, fathers, or brothers—under the pretext of preserving family honor or exerting control. While victims have primarily fallen within the 15–35 age range, 2024 saw an expansion: the youngest victim was just two months old, and the oldest was 86 years old. This shift underscores that femicide affects even more vulnerable groups, including infants and elderly women, exposing the depth of the crisis.

A particularly disturbing trend is the high and rising number of unidentified victims. In 2022, 60% of victims remained unnamed, increasing to 66% in 2023. By 2024, nearly two-thirds of femicide victims still lacked public identification. This growing trend reflects not just censorship but the systematic erasure of victims’ identities, making it harder to achieve justice or raise awareness.



Beyond domestic and honor-related killings, state-perpetrated murders have also risen. The Iranian government executed more women in 2024 compared to 2023, in some cases for killing abusive husbands. These state-sanctioned executions reinforce a justice system that punishes women who attempt to escape violence rather than protecting them.

Given the challenges of data collection in Iran, this analysis can only identify tentative trends. However, the persistence of high femicide rates underscores the continued failure of both the government and civil society to address gender-based violence. Without significant policy reforms and increased protections, femicide will remain an unchecked crisis.



RECOMMENDATIONS

The analysis of the recorded femicide cases shows the need for measures to prevent and respond to cases of femicide in Iran. SFI recommends civil society, Iranian government, and international community to adopt the following measures:

Recommendations for Civil Society Actors:

- **Expand Awareness and Prevention Initiatives:** Civil society should enhance grassroots campaigns to deepen public understanding of femicide's impact on families and communities. These initiatives should address underlying causes, effective conflict de-escalation strategies, and safe reporting mechanisms for at-risk individuals.
- **Strengthen Documentation and Research:** To develop an accurate and up-to-date database, civil society must broaden the scope of femicide documentation efforts. This includes tracking trends, analyzing patterns, and identifying targeted prevention and response strategies. Additionally, further research is needed on suicides among women and girls at risk of femicide to understand root causes and expand support services.
- **Advocate for Legal and Policy Reforms:** Civil society actors should push for legislative changes to explicitly criminalize femicide, close legal loopholes, and remove discriminatory provisions that enable perpetrators to evade justice. Advocacy should also focus on strengthening protections for survivors of domestic violence, ensuring access to legal aid, and holding authorities accountable for inaction.
- **Engage Religious and Community Leaders:** Religious and local leaders should be encouraged to use their influence to condemn femicide, challenge harmful gender norms, and promote interpretations of religious teachings that reject violence against women.
- **Improve Survivor Support and Protection Mechanisms:** Civil society should work to expand access to shelters, psychological support, and legal aid for women at risk. Community-led protection networks and safe reporting channels should be developed to ensure that women facing immediate danger have pathways to safety and justice.

Recommendations for the Iranian Government:

- **Invest in Prevention and Awareness:** The Iranian government should allocate resources to nationwide prevention programs, mental health services, and educational campaigns aimed at changing societal attitudes and behaviors that perpetuate violence against women and girls. This should also include conflict-resolution mechanisms and education so that families solve their disputes without resorting to violence.
- **Engage Local Stakeholders:** To ensure culturally sensitive and effective solutions, the government should collaborate with local and regional stakeholders, including both men and women, to identify and implement measures tailored to the specific needs of marginalized communities.
- **Mobilize the Religious Community:** The government should urge religious figures to speak against violence against women in general and femicide in particular, highlighting that these practices have no ground in interpretations of religious texts.
- **Reform the Legal System:** A nationwide consultation process is needed to address gender bias in the legal system and ensure effective punishment of femicide perpetrators. Law enforcement must also strengthen efforts to promptly and impartially investigate and prosecute femicide cases.
- **Ensure Transparency and Accountability:** The Iranian government should compile and publicly release disaggregated data on femicide and executions, including any potential gender bias, to enhance accountability and inform future policies.

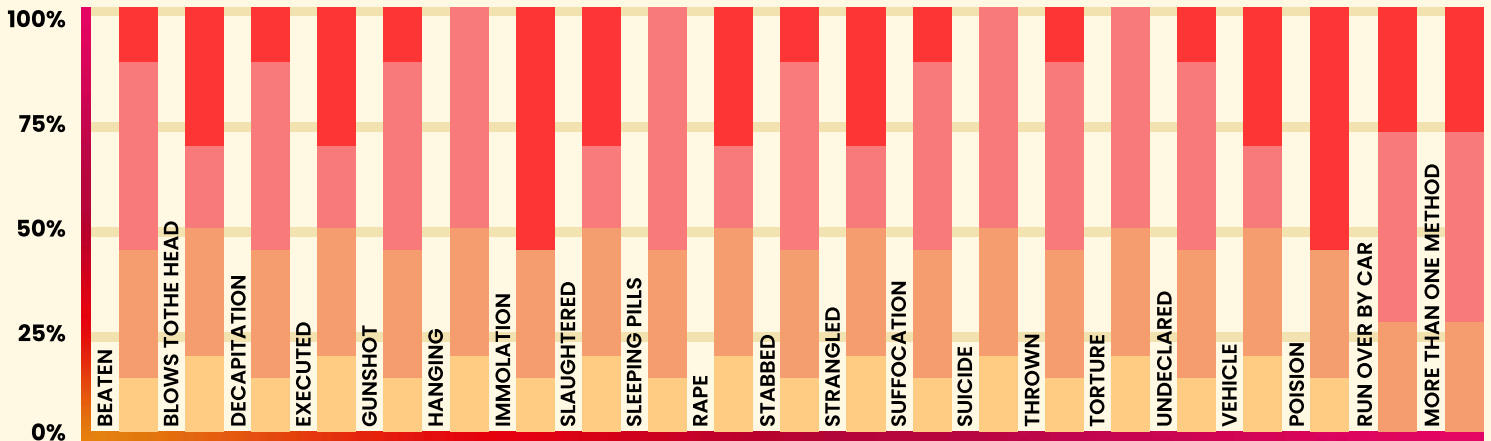
- **Uphold International Commitments:** The Iranian government must adhere to its obligations under international human rights law, particularly the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW), and protect women from femicide, whether committed by private individuals or state actors.

Recommendations for the International Community:

- **Pressure on the Iranian Government:** The international community should use diplomatic channels to hold the Iranian government accountable for addressing femicide and ensuring justice for victims.
- **Support Civil Society:** International donors should allocate funding to research femicide, assist women and girls at risk, and support programs for affected families and advocates. Additionally, funding for capacity building, training, and networking should be prioritized to strengthen the work of civil society organizations.
- **Show Solidarity to Iranian Women:** The international feminist community must support Iranian women without prejudice, rejecting any cultural justifications for femicide and advocating for their rights to live free from violence.

● 2021 ● 2022 ● 2023 ● 2024

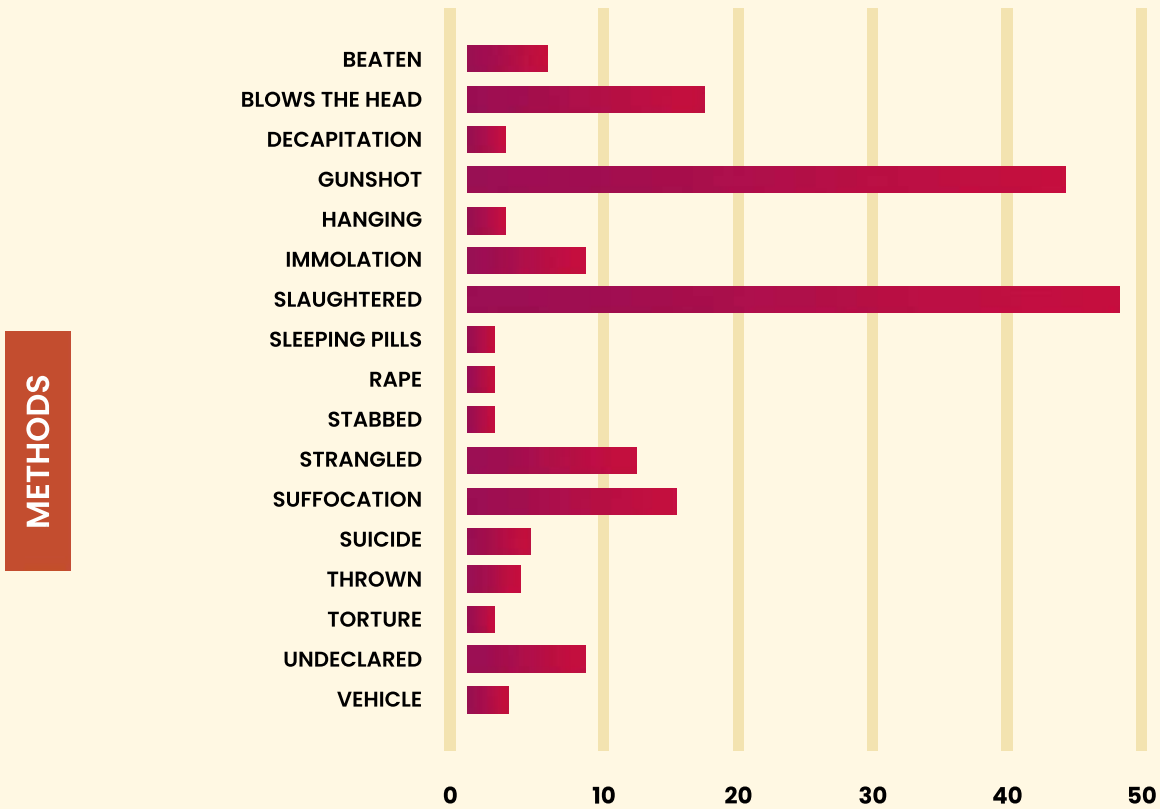
